From Long Island Expressway (I-495): LIE East to Exit 62, Rt. 97 (Nicholls Rd.), North Approximately 6.5 miles to Route 347 (Nesconset Hwy). Make left at light onto Rt. 347. Proceed West 1.6 miles to Moriches Road on right (After Sports Authority). Make Right onto Moriches Road. Continue north 1.2 miles to Mills Pond Road (at Stop Sign). Bear Right onto Mills Pond Road and proceed approximately 1 mile to entrance to **Flowerfield Fairgrounds** on right.
